Last year the prestigious title was awarded to the Police and Border Guard Board.

Risk management is growing in importance every year. It is an issue to which both the public and private sectors are turning greater attention. There is a person in almost every organisation who is responsible for risk management, because the world around us is becoming more complicated and the success of an organisation depends on the quality of its risk management.

The umbrella theme of this year's conference, 'Risk & Trust', was chosen because so much of what we do in our everyday work and relationships is based on trust. The fortunes and future of many organisations are decided by trust, or a lack thereof. Trust is something which is difficult to win but very easy to lose. One of the roles in risk management in the future will be shoring up trust and thereby boosting an organisation's competitive ability.

The conference will examine what is happening in the economy and the future of the technology sector. We will be discussing the greatest risks and challenges of open society, assessing the processes taking place in cyber space and talking in greater detail about data analysis and the data protection regulation in the context of risk management. The day will conclude with a panel featuring recognised experts from their fields discussing the future of cyber security.

Anyone who deals with risk management on an everyday basis as part of their work and who wishes to contribute to a safer society is welcome to attend the conference.




